The Higher Education White Paper runs to 80 pages and is arranged in six chapters. This guide focuses on the policy initiatives identified in the Executive Summary but cross-references them to the paragraph in the main text. Annex A of the White Paper sets out the consultation process for the various elements of the policy.

Chapter 1: Sustainable and fair funding (page 14)

- HEFCE funding for teaching will decline while graduate contributions will increase (1.5)
- HEFCE will allocate residual teaching grant to support priorities including Medicine, Science and Engineering (1.10)

Chapter 4: A diverse and responsive sector (p.46)

- Open up HE, FE and alternative providers' market according to consumer and societal needs (4.6)
- Free up to 85,000 student numbers in 2012/13, with the unrestrained recruitment of 65,000 high achievers (AAB+ at A-Level); allowance of up to 20,000 places extra for each good quality HEI charging up to £7,500 (4.19; 4.20)
- Employers and charities to have more flexibility over funding student places outside government number restrictions (4.22; 4.23)
- Consult on changing HE access criteria and the process of degree award (4.26)
